



## **Archery New Brunswick (ANB) Policy – Tournaments and Championships**

**Effective date: January 1, 2024**

### **Purpose and scope**

The purpose of this Policy is to define the annual archery championships held in New Brunswick as well as the additional requirements of scheduling, eligibility, fees, format of the tournaments, the Hosting Club's responsibilities as well as to define the rules applicable for annual ANB Championship tournaments and ANB sanctioned tournaments.

Amendments to this Policy are approved by the Board of Directors.

### **Policy**

#### **1.0 ANB may hold any of the following Championship tournaments annually:**

- a) A tournament to determine the Indoor Target Archery Championships and 3D Indoor Archery Championships of ANB may be held on or about the third weekend of April in each year. The tournaments will be scheduled for one weekend and will coincide with the Board of Directors meeting.
- b) A tournament to determine the Outdoor Target Archery Champions, the Field Archery Champions, and the 3D Outdoor Champions of ANB may be held prior to Nationals of each year.
- c) A tournament called the Canadian Regional Indoors may be held each year in accordance with Archery Canada's scheduling requirements. With the Board's approval two (2) sites, one in the north and one in the south of NB may host providing it is the same weekend however not the same day.
- d) A tournament called the Atlantic Regionals may be held each year in accordance with the rotation schedule agreed to between the Atlantic Provincial Sports Organizations (PSOs) for Archery.

## **1.1 Rules for scheduling tournaments**

- a) Each year at the Meeting of the Board of Directors held in September the Vice President shall accept bids from any affiliated Club wishing to host any ANB sanctioned tournaments and the ANB Championship tournaments. During this meeting, the Board agrees to and lists all the indoor and outdoor tournaments for the coming archery seasons. The tournaments will be marked as “registered” or “non-registered”.
- b) There will be only one event of a style (3D/target) on a specific day or weekend. For example, a 3D tournament on Saturday in Moncton and in Bathurst on Sunday on the same weekend will not be allowed. Also for the indoor season there would not be a 3D and a target tournament the same day with the following exception. For the outdoor season archers tend to be more committed to one style of archery and thus a 3D and a target event could be held the same day but the one style of archery event per weekend would be maintained.
- c) From the various bids the Board of Directors shall decide by a majority vote which of the bids will be accepted.

## **1.2 Annual Tournaments’ Eligibility & Fees**

- a) To qualify for awards at any ANB sanctioned or Championship tournaments all archers must be registered members of ANB prior to commencement of the tournament.
- b) All clubs hosting a tournament must ask and confirm that archers have a valid club membership card and/or ANB card. Non-members can purchase an ANB membership from the hosting club.
- c) ANB must provide the hosting club with a list of currently registered/renewed ANB members.
- d) The Board of Directors shall set tournament and hosting fees, if any, for all classes of entrants and all types of tournaments.

### Hosting fees:

- A club wishing to register a registered tournament by listing it on the Archery NB Website will pay a fee of \$75 per event.
- A club hosting a Provincial or Atlantic tournament will pay a fee of \$125 per event.
- A club wishing to register a fun shoot or non-registered shoot shall pay a fee of \$50.
- The treasurer will issue invoices to the clubs.

- Clubs must notify the Vice President which tournaments they want registered; the Vice President is required to register those tournaments with Archery Canada and/or World Archery.

### **Tournament Fees:**

#### **Club Tournaments**

- Adult - \$30.00
- U18 - \$15.00
- Family - \$55.00

#### **Provincial Championship Tournaments**

- Adult - \$40.00
- U18 - \$20.00
- Family - \$75.00

#### two-day events

- Adult - \$70.00
- U18 - \$30.00
- Family - \$125.00
  - Discount only applies if the same club is hosting a two-day event over two consecutive days.

### **1.3 Format of ANB Annual Championships and ANB sanctioned Tournaments**

a) All tournaments shall be run according to the rules of Archery as approved by the Federation of Canadian Archers (also known as Archery Canada and herein after referred to as AC) giving regard to its type and format.

b) The Indoor Target Championship shall be a one day affair and will consist of a FITA 1 round (60 arrows).

c) The Outdoor Target Championship shall be a one day affair and will consist of two 720 rounds of (72 arrows).

d) The Field Archery Championship shall be at least a one day affair and consist of one FITA Field Round.

- e) The 3D Outdoor Championship shall be a one day affair and consist of at least two rounds of twenty targets.

#### **1.4 Hosting Club Responsibilities**

The following duties and responsibilities must be accepted by any Club submitting a bid to Host an ANB Championship event:

- a) That all equipment and facilities provided or acquired by the Host Club to conduct the Championship event will meet current Archery Canada rules and standards.
- b) That at least ten (10) days before the Championship event the Host Club must forward complete event information and entry forms to all ANB affiliated Clubs.
- c) That within ten (10) days of the completion of the Championship event the Host Club shall present the following documents to the ANB:
  - i) A financial report of the event.
  - ii) Complete list of award winners and scores attained at the event.
  - iii) Complete Technical Committee report on the event.

#### **1.5 Rules, Titles, and Awards for annual and local tournaments**

- a) Archery Canada (AC) tournament rules shall apply.
- b) For ANB Provincial Championships and ANB sanctioned Tournaments awards shall be presented to the ANB members as described in the AC tournament rules for each event type. For local tournaments, clubs may accept non ANB members who hold an Archery Canada membership number but as non-competitive participants only.
- c) A hosting club may accept archers from other provinces to compete at our Provincials. Hosting clubs will ascertain they are a member of their resident province's PSO. Such shooters may get a medal for their performance in a "Guest" category.
- d) An archer who wishes to compete in multiple categories on the same day will only be permitted to submit the scores for the first category he/she is registered for the day of the event. These scores will be the ones eligible for national, provincial and event recording and event category placement.
- e) An archer is allowed to shoot a second category on the same day, however those scores are not eligible for any national, provincial or event recording or event category placement.

- f) For all annual ANB Championship tournaments, the Hosting Club shall appoint a Director of Shooting/Provincial Judge and such other field officers as required by the AC tournament rules and the expected number of participating archers.
- g) For all ANB sanctioned tournaments, the local club shall appoint a Provincial judge as described in the AC tournament rules.
- h) Clubs that hold tournaments not on ANB's tournament schedule shall not use the resources of ANB to promote such events and shall inform archers that such tournaments shall not count for financial assistance from ANB nor from AC.
- i) Archery NB will provide the medals for the indoor and outdoor Provincial Championships (Target and 3D) at no cost to the host club.
- j) ANB judges shall receive a fee of \$50 for each tournament they officiate (local, registered or provincial championships). The hosting club is responsible to find judges as required for all sanctioned tournaments and championships. Archery NB will reimburse clubs the \$50 judge fee, upon receipt of a claim or invoice. If Judges have to travel more than 100km (one way) to officiate at a tournament, Archery NB and the host club will reimburse the official for mileage according to our Travel policy on a 50/50 basis (this too shall be included in the claim for the judge's fee). Clubs will ensure that, for tournament registered with Archery Canada, a Provincial Judge Candidate or higher will officiate all such tournaments (Provincial Judge or higher for Provincial Championship).
